Opening

Vice President General for the Western District, Derek Brown, gave his remarks: As Vice President General – Western District, I bring personal greetings from our President General, who wishes us a successful conference. He believes the 250th Anniversary will be the best opportunity this Society has to capture the American people's attention and to attract and retain new members. Our focus must remain on educating the public and prospective members on the importance of the American Revolution and why we must continue to celebrate the accomplishments and sacrifices of our Patriot Ancestors who fought, struggled, suffered, and gained our liberty and independence. The California and Hawaii Societies are leading with legislative efforts to create and support America 250 Commissions in their states and all three societies in the Western District have developed unique and successful strategies to fulfill the National Society's mission statement.

<u>Bylaw Revisions</u>

David Hess submitted presented to the attendees, a number of largely cosmetic changes to the Society Bylaws.

Among those changes were adjustments to the Secretary and Treasurer responsibilities. When the Secretary and Treasurer's positions were separated in 2018, the bylaws no longer matched the business model being used by the two officers. Rather, a Secretary Treasurer Manual was developed and contained the details of their respective duties. Thus the recommended Bylaws changes now refer to this manual as the primary guide to their respective responsibilities.

A second change was the elimination of a standing audit committee. It was the recommendation of the Society officers to appoint a committee as deemed necessary. This follows suit with the various other committees which are appointed as required.

No discussion took place about the cosmetic changes nor the Secretary and Treasurer duties, however some members were concerned that the Audit Committee was being eliminated, and that this was not keeping with the National guidelines. President Jay Dickey assured them that we were well within our society's right to move the Audit Committee from a standing committee into an ad hoc Committee that could be created anytime it was necessary.

Once the discussion a **motion was made** and seconded and the bylaw changes were **passed as recommended**.

Paul Jones Memorial Scholarship Fund

The next order of new business was about the Paul Jones Memorial Scholarship Fund. Secretary David Hess gave a report of the status of the scholarship and announced the two winners for 2023. Claire Halminiak and Cassidy Husson were each recipients of a \$500 Scholarship.

Election of State Society Officers

The final new business was the report of the State Nominating Committee re Election of State Society Officers. Once again Secretary David Hess presented the slate of officers for approval.
